## **Directions and General Recommendations**

SEAMAX is recommended for use on all crops including: alfalfa, almond, apple, apricot, asparagus, avocado, banana, barley, beans, berries, brassica, cacao, carrot, cherry, citrus, coffee, corn, cotton, cucurbits, field and row crops, forage crops, fruit trees, grains, grape, hops, kiwi, leafy vegetable, legume, mango, nut trees, onion, ornamental, papaya, peach, peanut, pear, pecan, pepper, persimmon, pineapple, pistachio, plantain, plum, pome fruit trees, potato, prune, rice, root and tuber vegetables, small fruit, sorghum, soybeans, stone fruit, strawberry, sugar beet, sugar cane, sunflower, tomato, stone fruit, tropical fruit, vegetables, walnut, and wheat.
